There are handicapped parking spaces at In the parking lot on George Wise Street and the nearby parking lot including for tall cars.

- There is a continuum of access from the parking through the entrance to the reception center, and until the service is received.
- The reception center includes accessible service posts.
- If needed, you may ask the service representatives for assistance in completing forms.
